By: Ian Rutter, This has been about the rainiest August anyone can remember. We're barely into the month and already received more than the average rainfall of just over two inches. Tailwater generation remains grim but the creeks are really doing well. After three years of extremely dry summers it's sure been good to see the streams looking good all season. Water temperatures have been excellent in the mountains. Lower elevation streams like Little River have rarely been exceeding 65 degrees. Just a few days ago the water at the head of Tremont was 60 and water several miles upstream at the junction of Lynn Camp and Indian Flats Prongs was 58. Almost any stream you'd want to fish should be fishing well. However, larger streams like Tellico River, Little River, and Abrams Creek will definitely fish better with nymphs during the day. Try basic patterns in #14-16. Pocket water is the place to find wiling fish in the middle of the day. There will be sporadic pods of rising fish in long pools but expect them to be difficult, working midges. The smaller, higher elevation streams are really producing with dry flies. Thunderhead and Lynn Camp Prongs have been consistent producers with local fishermen this season.

Fishing Pick FROM PAGE 1 The only trouble is passing up all that great water on Middle Prong to get there! Upper Little River above Elkmont has also been great with fish coming consistently to dry flies.

This is a great time of year to hike into backcountry locations and fish over uneducated trout. The days are plenty long and waders aren't needed. Just pack a lunch and water bottle with your rod and vest. Some of the best locations in the Smokies are Deep Creek, Bradley Fork, and Big Creek. All of these streams have extremely light fishing pressure and do well in the summer. In the Cherokee National Forest you might also consider hiking into Bald River, North and South Forks of Citico Creek, and Sycamore Creek. Be sure to pack a light rain jacket because rain is always a possibility with the weather pattern we've been in.

We should have an excellent fall season ahead of us. We've got a good head of water to pull us through and the autumn color should be the best we've seen in years.

Legislative Liaison Job Description

Duties: Legislative Relationship-Building, Council Updates, Calls to Action Time Commitment: Approximately one hour per month.

1. You are responsible for maintaining contact with your legislators. Contact includes an occasional "heads up" on relevant coldwater issues, approximately every two months. This can be via e-mail or phone calls.

You will be provided with a bio of each of your state and US legislators. It will include a picture, district address and phone, Nashville/Washington address and phone, e-mail address, biographical information, public information, community involvement information. The chairman of the Stewardship Committee will also work with you to help you become comfortable in developing your relationships and making contact.

2. You are responsible for keeping the Stewardship Committee up to date on your personal preferred contact information and on coldwater issues affecting your chapter. This can be via e-mail or phone calls.

You will be provided with Stewardship Committee contact information.

3. You are responsible for responding to "Calls to Action."

When "calls to action" arise, the Stewardship Committee, who will provide background information and talking points about TU issues, will contact you and request that you pass this information to your chapter and appropriate legislator.

Lamar Alexander Update

At the last meeting I mentioned that Bill Frist and Lamar Alexander made a new release that an appropriations bill they sponsored passed the Senate Appropriations Committee and it included more than \$12 million for Tennessee. There was \$2.36 million for the GSMNP to rehabilitate comfort stations and picnic/camping grounds. BUT Several people spoke up and ask about newspaper articles they read that Senator Alexander was proposing this money for rapid transit in Cades Cove.

I call Alexander's office and found out that yes there were probably both stories in the papers but they were totally unrelated. Separate unrelated bills one that including \$2.36 million for the Park, and bill another that Alexander has expressed support for to make funding available for studying transit in all national parks. No particular park was pointed out and there should have been no mention of GSMNP or Cades Cove. So that is the word directly from Alexander's office. Tom Eustis

Tail: Natural Woodduck flank fibers **Ribbing:** 2 strands of Gray Ghost Krystal flash, twisted and spiraled

Wing Wingpost: Strip of Yellow dry cell Fly Foam

Hackle: Light Blue Dun, undersized, tied parachute style

Abdomen: Dark Olive/Brown Antron dubbing

Thorax: Mixed Pale Olive & Pale Dun Antron dubbing
